

Manager's Message

Hello!

I'd like to thank everyone who took time to out of their busy life to send me warm wishes of "welcome" to Montclair and my new position of General Manager. I appreciate the support!

One of my professional passions is developing a deep sense of "neighborhood belongingness" among the residents. It's so easy in this busy life to keep to ourselves and not get to know one another. You can create this connection through community awareness.

Community awareness is not a topic you hear often in the association management field. It's a very "business" oriented focus most of the time. However, the best communities balance between business and personal activities to foster that "neighborhood vibe" which has been shown conducive to resident satisfaction. In short, everyone likes to feel that they are not just writing a check to support a business, they want that personal connection.

Are you familiar with the day-to-day habits and routines of the other residents in your community? Would you notice if your neighbors deviated from their normal patterns? Knowing their routines enables you to quickly realize when something is awry, especially for residents who live alone. And in a true emergency, that awareness could literally save a life.

Neighbors who are also friends are more inclined to look out for each other and have each other's phone numbers, so make an effort to befriend the residents who live near you. Many boards of directors find that hosting community gatherings is an excellent way to encourage new friendships. Perhaps a yard sale, ice cream social, association picnic, or some other event would give your community an opportunity to grow the bonds of friendship?

Even if you're not close friends with your neighbors, make a point of keeping an eye out for these telltale signs that a neighbor may need your help:

- A stack of newspapers. Chances are that your neighbor isn't simply away if newspapers begin to pile up at the front door. People who are traveling usually stop delivery or ask a neighbor to pick up their newspapers.
- Unkempt lawns. Signs of neglect may not simply mean they don't want to mow. There may be other reasons which prevent a resident from keeping their yard maintained. Talk to your property manager when you see something awry so they can help.
- Overflowing mailbox. Similarly, someone who is traveling will have their mail held at the post office or ask a neighbor to collect it. A bulging mailbox could indicate a problem.
- No one driving out. If your neighbor has a regular driving routine (for example, leaves for work at the same time every day) and suddenly doesn't leave the house for several days, check in on them. Sure, it's possible they are just taking some time off, but it's best to verify.
- Missing a daily walk. Someone who routinely walks through the neighborhood at the same time every day –
 especially if that walk involves a pet could need help if they aren't following their normal routine.
- Neglecting to answer the door. Although it's possible that you didn't notice your neighbor leaving, a fall or
 other health issue could also be the reason someone doesn't respond to a knock or doorbell. Never attempt
 to break into someone's home, however, even if you're worried about their wellbeing. Instead, contact your
 property manager or ask the police to do a wellness check.

Creating a sense of community involves more than just being a member of the board of directors. It also means caring about the people who live around you.

Boat and Dock Permit Registration Starts in October



Starting October 1, 2019, the MPOA office will be accepting Boat Registration and Dock Permit Registration forms for the October 2019 to September 2020 season. The forms are available at the MPOA office or on our website at www. montclairva.com. Both forms must be submitted to the MPOA office no later than October 31, 2019.

Boat Registration

Any resident operating a boat on Lake Montclair is required to register with MPOA. Residents who do not register their boats by November 10, 2019 will incur a \$15 late fee. Additionally, any boat stored at the West Beach boat racks is subject to a \$25 annual storage fee. Boat stickers are to be attached to the port (left) side of the bow (front).

Please have the following items or information at the time of registration:

- MPOA sticker number (orange sticker with four-digit number)
- Color of boat
- Serial/hull number
- Boat length
- Motor hp/thrust
- Current photo (if not already provided)Location of where it will be stored

Dock Permit Registration

Any lakefront homeowner with an approved dock is required to renew the Dock Permit Application annually.

Please have a copy of your current General Liability Insurance of no less than \$1,000,000. In addition, the MPOA must be listed as certificate holder or as additional insured (when available) at the time of registration.

Now that school is in session, driving the posted speed limit is especially important. I mentioned this last month, but its importance bears repeating. Hundreds of children and parents walk to school daily. We have two marked school zones along Waterway Drive that are 25 mph when the yellow lights are flashing. There is another zone on Tallowood Drive approaching Montclair Elementary School. Thank you for maintaining 25 mph in these zones!

Trash Update: The board voted to accept a proposal from Bates Trucking and Trash Removal in July. However, I could not sign the contract because it contained numerous discrepancies compared to the original proposal. Bates has not agreed to our terms as of the time of this writing. They are concerned about not servicing 100% of the Association and having 3,000+ invoices to manage. We need to become a "single payer" Association to attract a new trash hauler. In the meantime, we remain engaged with American Disposal. They are training new drivers and plan to be on a regular schedule soon. The MPOA will provide more information in via email blasts, the Facebook page, and The Montclairion as we have new information to share.

Public Notice

As approved at the August 14, 2019 Board of Directors meeting. These ammendments will go into effect October 1, 2019.

Public Notice Key removed text added text

Amendments to Community Guidelines Article 3 Section 3.3.1 (d) Standing Committees

d. Communications Committee – The Communications Committee provides creative and technical methods to enhance all avenues of communications within the community as well as between the BOD and members of the association. The committee also suggests methods of facilitating information flow from sources outside of the Montclair community. These avenues of communication include but are not limited to the MPOA web site, the MPOA Facebook group page, the Montclairion, FSR Connect, mailings, and community bulletin boards.

Amendments to Community Guidelines Article 4 Section 4.3.5 (j) Boating on Lake Montclair

- j. For purposes of the Community Guidelines, a "boat" is defined as a vessel propelled by oars, paddles, sail, or electric power and having the following characteristics:
- 1. Over 6 feet in length but not exceeding eighteen (18) feet, and having no more than one deck.
- 2. Constructed so as to have a hull, frame, body or casing made of durable and water repellent material or pontoons attached which provide the flotation necessary for the buoyancy of a main platform (i.e., pontoon craft).
- 3. Have the capacity to accommodate a passenger with a life preserver on board unless designed for one person only.
- 4. Routinely propelled with standard oars, paddles, sails, or small electric motors.
- 5. Paddleboards are exempt from the above definition and not considered a "boat."

Amendments to Community Guidelines Article 4 Section 4.3.5 (a) Boating on Lake Montclair

a. All boats regularly used on Lake Montclair shall display a current MPOA registration. Canoes, kayaks, and paddle boards that are rented, borrowed or owned by authorized guests may be used on an infrequent basis without MPOA registration when accompanied by a valid MPOA Recreation Photo ID. All boats shall be registered annually in October at the MPOA office and shall display a current MPOA sticker on the port side of the bow. All boats must be maintained in good working order and appearance and shall be operated in accordance with federal, state and local requirements including, but not limited to, all requirements with respect to loading, life preservers and safety equipment. No boat of a length greater than eighteen feet shall be launched onto or used on the Lake without expressed consent of the MPOA Board of Directors. No boats may be moored or left unattended on the Lake after dark and before dawn except at the boat owner's own MPOA approved dock. The owner of any boat moored on the Lake overnight shall register on the Armstrong Connect webpage and shall provide management a telephone number or numbers at which the owner may be contacted.

Amendments to Community Guidelines Article 3 Section 3.3.1 (i, j, k) Standing Committees

- h. Planning, Environs, Land Use, and Transportation Committee (PELT) The PELT Committee monitors those matters which might have an impact on the community. When appropriate, the committee acts in the community's interest as a liaison with are developers, businesses, and local government agencies. Some of the PELT Committee issues include planned area development with particular concern over the Powells Creek watershed, environmental dumping, and community promotion;
- i: h. Safety Committee The Safety Committee provides review of policies, safety procedures, related statistical data and communication of such to the MPOA membership and makes input to the BOD to enhance and maintain safety within the community. Recommendations and actions of the Committee are to promote and support safety awareness and membership participation in programs such as Neighborhood Watch, general safety measures and crime prevention; and
- j. Sub-Association Committee The Sub-Association Committee is intended to be a working group to provide a communication forum to explore awareness between the associations. The Committee will also provide opportunity to identify common cause and synergy of action between the associations:

The Montclair Seahawks Swim to Success!

The Montclair Seahawks summer swim team completed another successful season on July 27, winning the Prince William Swim League 2019 Orange Divisional Meet held at the Montclair Country Club.

Head coach Julie DeNard led the Seahawks to victory. The team had a 5-1 record coming into the divisional meet and scored 4032.5 points, defeating the Old Bridge Breakers (3773.5 points) and the Veterans Park Marlins (2983 points).

After losing to Old Bridge in 2018 and 2019 by hair-thin margins of 20 and 9 points, respectively, the Seahawks were expecting another close meet and came out fighting. The team took first among the three teams in 6 of the initial 11 relay races and never relinquished that lead.

The 13- and 14-year old boys were a key to the victory, sweeping all the top five spots in freestyle, three of the top five in the individual medley, four of five in backstroke, and three of five in butterfly. The 13- and 14-year old girls took four of five top spots in butterfly, and the 8- and-under girls took four of the top five spots in backstroke.

Longtime Montclair swimmer Jaret Lewis broke a team breaststroke record in the 15 to 18 age group in his final meet as a Seahawk. Swimmers who earned individual honors for posting times in the top 24 across the County

included Benjamin Avelis, Isabel Frederick, Michael Frederick, Jaret Lewis, Ella Mosley, Jack Supon, Samara Ussher, Kezia Ussher, and Katelyn Viggiani.

The coaches are especially proud of the team's development of less experienced swimmers. Several swimmers who couldn't swim across the pool to compete in the first meet of the season were able to swim freestyle, backstroke, and breaststroke in the divisional meet and 90% of the team's 8-and-under developmental swimmers participated in at least one meet during the season.

The team was over 150 swimmers strong this season, with the majority being residents of Montclair or attending Montclair-area schools. The team is looking forward to expanding the developmental program to get even more local kids in the water in the coming years!

The Montclair Seahawks summer swim team is an independent 501(c)3 public charity, not affiliated with the MPOA, that has competed in the Prince William Swim League for over 45 seasons. The Seahawks home pool is the Montclair Country club, but neither Country Club membership or Montclair residency are required to join the team. Swimmers at every level are welcome and registration for the 2020 summer season will begin in March 2020!







COVENANTS UPDATE by Armin Neuman, MPOA Covenants Manager

What is a PIR? How do I ensure it's completed before I submit?

A Property Improvement Request (PIR) is required for all additions or alterations that are not same-forsame or listed as Pre-Approved per Article 5 of the MPOA Guidelines. The top portion of the PIR requests your basic information as a Montclair homeowner. Please be sure to provide a current phone number and email address; this information will be important while processing the PIR if we need clarification on your application.

The second portion of the PIR is where you will provide us your detailed proposed alteration/addition to your property. The signature line on this document must be completed by the current owner of the property. Please be sure to reference Article 5 for what specific information must be included with your request (i.e. dimensions, color sample, current photo, drawing, property plat, etc.). Please be sure to read the boxed-in information carefully.

Lastly, the final portion requires four (4) neighbor signatures. These neighbors can be next door or adjacent from your property. The "Notify Me" check-box is available if your neighbor wishes to be notified of the date that your PIR will be reviewed.

Why do I need neighbor signatures?

The four (4) neighbor signatures are required to complete your PIR application and forward it for processing. The neighbor signatures do not constitute your neighbor's approval or disapproval. Neighboring homeowners are signing simply as an acknowledgement of your proposed plans. Homeowners with concerns regarding the PIR may contact the MPOA office within five (5) days for the Covenants Committee review.

Will someone be on my property?

Yes, the Volunteer Covenants Committee Members will be reviewing your property prior to voting on your application. Your PIR Acknowledgement Letter will reference the dates that the Covenants Committee Members may be out to review your property. This will provide an opportunity to speak with our Covenants Volunteers on-property regarding any questions or concerns you may have about your PIR.

Who are the Covenants Committee members?


The Covenants Committee currently consist of seven (7) Montclair homeowners. They take time out of their busy schedules volunteering to ensure that your application is reviewed on-property and voted on during the Covenants Committee Meetings. All Covenants Committee Members wear an identification badge provided by MPOA while reviewing properties.

My completed PIR has been approved by the Covenants Committee, now what?

Congratulations! The Montclair office will provide you a letter stating that your application was approved by the Covenants Committee for your records. The approval letter will specify that you are to take no action to begin the approved work during the ten (10) day period from the date of the notification, pending any possible appeal to the Architectural Appeals Board (AAB) by an objecting property owner, pursuant to Sec. 5.2.2 (d) of the MPOA Community Guidelines. If an appeal is not received within the ten-day time frame, the decision of the Covenants Committee is final.

All approvals are contingent upon compliance with the specifications set forth in the approved application to include the above stated stipulations. As the homeowner, you are responsible for obtaining all required zoning approvals and county permits for your change or addition.

Additionally, if the work has not commenced within one year from the date of committee approval, you will be required to reapply for the intended alteration/improvement. Covenants staff will re-visit your property after the one-year mark of your approval letter to ensure that your alteration/addition was completed per your PIR approval.



The Tamponathon Returns to MPOA

The annual Tamponathon collection at the MPOA office begins on Monday, September 2, 2019 and runs through Monday, September 30, 2019 during business hours. Initiated a few years ago by Montclair resident,

Emma Young, the Montclair Moms group was instrumental in making the feminine hygiene product drive for distribution to shelters, homeless outreach organizations, and schools a huge success, garnering positive press for the community.

"The collection effort for the Tamponathon here in Montclair is nothing short of astounding," said Montclarion Jennifer Palmer Lazzo. "Our community is always willing and able to help those in need, in a big way. Of the almost 13,000 personal products donated in 2018, the bulk came from Montclarions," she stated.

Lazzo, along with Montclarions Whitney Miller, Emma Young, and Sara Holt, delivered the donated tampons, pads, and reusable feminine hygiene products to school and shelters. "It was a humbling experience, delivering those donations. School nurses showed us bare cupboards and food pantries stocked empty shelves. If they can't afford food, they can't afford personal products," Lazzo said.

"As women, the members of the Montclair Moms Group

all have some experience in the arena of feminine hygiene and the simple act of donating can help immensely," said Montclair Moms' Founder Linda Cheng-Kahn. "From a homeless woman who can gain a little dignity with appropriate feminine hygiene products to a teenager needing supplies and being able to obtain them from her school nurse. Women can empower one another through empathy."

This year several Montclair Moms have offered their homes for gathering and organizing supplies, and several more have offered to deliver the supplies. "Each year we receive requests from more schools and outreach pantries, and each year Montclairions have risen to the challenge, ensuring no woman need to miss school or work. It is heart-warming and reflects Montclairions' generosity and community-mindedness," Young said.

COYOTE SIGHTINGS



There have been some recent reports of coyote sightings in Prince William County. Most sightings have been reported in or around Manassas, Lake Jackson Drive and Prince William Parkway, and specifically in the Montclair neighborhood on the following streets: Jonathan, Barrington, and Cliffview. As human populations continue to rise and move into traditional wildlife habitats, human/wildlife contact becomes more prevalent.

Coyotes are primarily nocturnal; however they are commonly seen during the day in urban and suburban areas and are usually attracted by a food source or appealing areas to make dens such as under porches/decks, crawl spaces, or outbuildings. The best way to prevent them from becoming a problem is to not give them a reason to take up residence in your community.

• If anyone in the neighborhood is feeding wildlife directly - or

indirectly - it can cause trouble for everybody. Feeding wildlife will cause coyotes and other wildlife to lose their natural fear of humans.

- Do not leave pet food outside; keep pet feeding areas clean.
- Remove bird feeders when problem species have been seen around them.
- Close up all openings under and into your buildings. Animals look for places to make dens and raise their young don't give them that opportunity.
- Clear fallen fruit from around trees.
- Keep brushy areas in your yard cut down to prevent cover for coyotes.
- Keep small pets inside and on a leash when outside; they
 may be viewed by a coyote as prey. Larger dogs are viewed
 as a threat, particularly from January to June while coyotes
 are mating and birthing pups. Keep dogs on a leash at all
 times when off your property.
- Install coyote proof fencing to protect unsupervised pets.

Authorities are telling people that if a coyote does approach them, which is unusual, they can make a lot of noise either by clapping, yelling or stomping their feet to scare the coyotes away.

If a coyote appears to be sick, injured, or acting aggressively, call Animal Control at 703-792-6500.

Take a Book, Leave a Book: Montclair's Free Little Library

Did you know Montclair has its own Free Little Library? If you're new to Montclair or haven't been to Kids' Dominion, you may not know that Montclair has a vibrant Free Little Library that has a constant stream of books flowing in and out of its cute little "house." Residents can take a book or leave a book - or both! Kids love stopping by and picking up a new-to-them book to bring home after a fun day at the park. Each resident can help by keeping it stocked with great stories, new releases and relevant reading material. It's a great way to share a story you loved!

Montclair's Free Little Library was donated by Patti Engstrom as a tribute to her cousin, Gene Broderson, a Montclair resident and advocate of children's literacy who passed away in September 2013.

The Free Little Library movement has humble beginnings. In 2009, Todd Bol of Hudson, Wisconsin, built a model of a one room schoolhouse. It was a tribute to his mother; she was a teacher who loved to read. He filled it with books and put it on a post in his front yard. His neighbors and friends loved it, so he built several more and gave them away. This caught the attention of other book enthusiast who were inspired by the growing network of "take a book, leave a book." Over time, Free Little Libraries began to pop up in coffee shops, parks, and public spaces. Now there are more than 90,000 registered Little Free Library book-sharing boxes in 91 countries worldwide.

Montclair History

Did you know?

In 1844, a post office was established at the home of Dewitt Alexander, at what is now Minnieville Road and Cardinal Drive. The post office was named Minnieville, after Alexander's youngest daughter, Minnie, Two years later, a school named Minnieville School opened across the street. The area surrounding these establishments became known as Minnieville.

Henry Dane owned 211 acres in Minnieville and his home became known as "Pilgrim's Rest" due to the hospitality extended to travelers.

The post office remained in service until May 31, 1924. The Minnieville name continued until the 1960s. With the development of Dale City and Montclair, the name faded into history.

Tips to Ease Back-to-School Anxiety



The start of the new school year is exciting for most kids. But it also prompts a spike in anxiety: Even kids who are usually pretty easy-going get butterflies, and kids prone to anxiety get clingier and more nervous than usual. Parents feel the pain, too. Leaving a crying child at preschool isn't anyone's idea of fun. And having to talk a panicked first grader onto the bus or out of the car at school can be a real test of your diplomatic skills.

Kids who normally have a little trouble separating from mom and dad will see their anxiety peak during times of stress or transition, notes Rachel Busman, clinical psychologist at the Child Mind Institute. The start of school may be especially challenging for kids who are entering a transition year, she adds — going into kindergarten, into middle school, to a new school. It can also be stressful if there's a change in your child's social support system — maybe a good friend has moved or has a different teacher this year.

For most kids the new-school-year worries will fade and the anxious behaviors will be transient, Dr. Busman adds. The goal for parents is to be supportive without exacerbating your child's worries. Here are tips for helping nervous kids have a successful transition back to school.

Take your own temperature

For parents, the start of the year can be anxiety inducing, too, Dr. Busman notes. The pressures on you to reinstate routines after the summer break and arrange for new activities and schedules, not to speak of facing the resumption of homework. Dr. Busman recommends taking your own temperature to make sure you're not passing on stress to your kids. And to enable you to manage your own stress, she says, it's important not to take on

more commitments than the family can handle comfortably.

Listen to worries

When kids express anxiety about going back to school — a new teacher, increases in homework, making a team, a friend crisis — do listen seriously. Rather than dismissing these fears ("Nothing to be worried about! You'll be fine!) listening to them and acknowledging your child's feelings will help him feel more secure. And if he wants to, you can bolster his confidence by helping him strategize about how to handle things he's concerned about. But keep in mind that kids often want to be able to talk about something they're upset about without expecting you to fix them. Your job is to validate their feelings ("I know that's hard") and demonstrate confidence that they can handle the situation.

Don't ask questions that suggest you expect kids to be anxious ("Are you worried about having Mr. Connelly for math?") but check in with them in a more casual way. "It doesn't have to be a half-hour discussion," notes Dr. Busman, "but in the car on the way to get a new backpack, you might ask "Do you know what you're going to be learning in math this year?" Kids often say more when there is less pressure to "have a talk."

Do some test runs

If you anticipate that your child will be seriously nervous on the first day, it helps to give her time to get used to the new school or new classroom in advance. Go to the school several times before school starts and do as much walking the halls as you can, to locate her classroom, the lavatory, the cafeteria, the playground. Repetition is good; going by again just to ask a question at the office, or drop

off a form, gives her more chances to get comfortable being there.

If you can, introduce her to her teacher. Let her practice staying in the classroom a few minutes while you walk down the hall to drop off a note the nurse's office. Even driving to the school on the weekend and having her practice getting out of the car at the drop-off point can help her get familiar with that routine.

Let someone know

If your child needs extra support to make a successful transition, let someone at school know — his teacher, an aide, the school psychologist or the school nurse. You want to communicate that your child is looking forward to school and is excited — you're sure he'll be fine — but he will be much more comfortable if he can meet the teacher briefly and see the classroom before the crowded, chaotic first day, when all the other kids will be there.

Arrange for a hand-off

If you think your child will be reluctant to separate, it's very helpful to have someone primed to meet and engage her when you arrive. Asking the child for help is a good way to do that — "Can you help me carry all the magnet tiles over to this bin?"

Giving the child a role is transparent, Dr. Busman notes. "They're not pretending the parents aren't leaving, but they're helping your child get involved in the classroom, be part of the community. Kids for the most part love to please adults and want to be part of the activity, so it can really help take their minds off anxiety."
